Thank you for your interest in the Setauket Country Fair. We appreciate your support. This event is held on the Setauket Village Green on Main Street in Setauket, across from the Emma S. Clark Memorial Library. We will have bagels and coffee available in the morning, a hot lunch, and a variety of homemade goodies for your enjoyment throughout the day.

The Country Fair includes: Exhibitors, Raffle Baskets, Barn Sale, Music, Hot Lunch, Bake Sale, Children's Games, Prizes and Crafts, Contest for all ages, Pony Rides, inflatables and more.

This event will be well advertised. Flyers will be sent home through our schools, signs will be posted on busy roads with write-ups in the local papers, news 12.com, cable, etc.

Fine Artists, and High Quality Craftspeople and Vendors are invited to show and sell their work at The Annual Setauket Country Fair, hosted by the Setauket Presbyterian and Caroline Churches .

Directions

1. Go north on Nicolls Road (CR-97), from Nesconset Highway (NY-347), the Long Island Expressway (LIE/I-495), EXIT 62, or Sunrise Highway (NY-27).
2. Follow Nicolls Road to the end.
3. Turn right onto NY-25A.
4. Go down 5 lights, make a left onto Main Street.
5. Village Green will be in front of you.

IMPORTANT REGULATIONS

1. Booth space is 10' x 10'. Bring your own tables, chairs and canopies. Exhibitors exceeding their 10'x10' space will be asked to pay for an additional space. Canopies are recommended for some spaces.
2. Rain date is Sunday, June 4th, NOON – 5:00PM. No refunds if you cannot attend the rain date.
3. An up-to-date photo that clearly represents your merchandise must be submitted with your application. Photos will be kept on file and will not be returned.
4. Merchandise sold shall only be items described in this application. We reserve the right to prohibit any exhibitor from exhibiting his/her merchandise at our absolute discretion.
5. Spaces assigned according to receipt of applications – return early. No refunds given for any reasons. There are no guarantees or changes regarding space you are assigned. We expect all locations to be busy and well viewed.
6. Examine your confirmation immediately. In case of an error, contact the fair vendor coordinators listed below.
7. Set up will begin at 8:00 AM the day of the fair and must be ready to show at 10:00AM, cannot strike until 4:00PM. Exhibitors discovering a problem on the day of the fair must accept the resolution of the fair coordinators.
8. All vendors must park off the Village Green by 9:30AM.
9. Exhibitors must remove all garbage at the end of the show and be off the Village Green by 5:00 PM.

Anyone found to be disregarding these regulations will be escorted off the premises without refund.
